## **Privacy Policy**

Data that might be required and processed can be the following:

name, surname, phone numbers of the company and/or related to a person, eventually personal or company's address, eventually Fiscal Code or VAT code, e-mail. They refer only to Companies or to Professionals.

As regards the activities of Diagnosis, Analysis, Consulting, Projecting on the basis of agreement and consent other data, details, information are required in order to allow S.B.S. Consulting running the activities.

## How S.B.S. Consulting manages the personal data:

- . collecting, recording, processing, organizing, filing, storing, changes, selection, comparison, usage, cancellation of data. Data are filed up and stored by means of informatic supports, in data-bases and on paper supports inside the studio processed by the Proprietor only. Thus, suitable criteria are adopted to grant security and confidentiality. No data being sent or processed by third party in the Studio or outside the Studio. Data can be managed only and exclusively inside the studio for analysis and statistics in aggregated way related to the business.
- . All data can be managed only for accomplishments related to our business in order to give information about the services offered by S.B.S.
